Update on the New and Potential Projects and Programs

- 1. Consistent with Strategic Priority Area 5 of the AFoCO Strategic Plan (2019-2023), "Strengthening institutional capabilities, diversifying resources, and promoting regional actions", the Secretariat has been sustaining its efforts to initiate and develop projects and programs to facilitate the achievement of the AFoCO vision while at the same time contribute to the attainment of forest and climate-related national, regional and global targets/initiatives.
- 2. In consultation with member countries, the Secretariat has so far initiating various projects and programs in partnership with relevant bodies/organizations as well as initiatives emanating from high-level discourses and commitments at the regional and international arena, such as the following:
 - a. AFoCO in cooperation with CIFOR-ICRAF and the Global Evergreening Alliance (GEA) are collaborating on Landscape Partnership for Asia (LPA) for the restoration of an initial area of 10 million hectares of drylands and drought-prone areas for 10 years. The work for LPA visioning/road map and sub-regional programming will take its course towards the end of CY2020 up to 1st quarter of 2021 leading to the eventual soft launching of the Partnership at the World Forestry Congress in May 2021. AFoCO host and manage the LPA Secretariat in terms of coordination, communication and administrative support to LPA.
 - b. The Secretariat in coordination with Korea Forest Service (KFS) and United Nations Convention to Combat Desertification (UNCCD) channel will facilitate project development initiatives for Peace Forest Initiative (PFI) as an active member of the PFI Regional Working Group. The project development has been initiated and will be further pursued as soon as the PFI Terms of Reference (ToR) has been issued by the UNCCD Secretariat.
 - c. The KFS has communicated to the Secretariat to advance the discussion on realizing the ASEAN-ROK Garden through AFoCO.
 - d. The Secretariat will be embarking on the development of a program to implement more forest rehabilitation and livelihood improvement activities with diverse stakeholders, through private sector support and funding. Likewise, as part of the Statement of Intent (SOI) between World Bank and KFS, the Secretariat is in the process of developing an e-learning course in Forest Fire Management (FFM) to complement with the regular on-campus FFM training course in the Regional Education and Training Center (RETC).

Roles of the Secretariat:

Facilitate project development (concept note/full proposal), cooperation/funding (in consultation with KFS) and project implementation

- 2. In line with the AFoCO resource mobilization strategy, the Secretariat consider developing a program to implement more forest rehabilitation and livelihood improvement activities with diverse stakeholders including private sector. The Secretariat will mobilize funds from individuals, groups, and businesses which will be used for the activities in our member countries.
- 3. As part of Statement of Intent (SOI) between KFS and World Bank (WB), AFoCO will serve as the organization that will facilitate any cooperation activity in line with the SOI. Initially, the Secretariat and WB are in the process of developing an e-learning course on Forest Fire Management (FFM) as a part of AFoCO regular training course on FFM, a blended type of e-learning course may be implemented to cover the fundamentals of forest fire management through e-learning and practical knowledge and skill level exercises during the on-campus learning in AFoCO RETC.
