Updates on the Special Account (project fund) of AFoCO and the Program Support Fee

Introduction

- 1. The 3rd AFoCO Donors' Meeting was held at the AFoCO Secretariat in Seoul, Republic of Korea on 26 February 2021. The meeting was attended by a delegation from the Korea Forest Service (KFS) and the Secretariat. According to the recommendation of the 3rd Donors' Meeting, the Secretariat has facilitated the project fund execution in cooperation with the respective Implementing Agencies.
- 2. As of 25 October 2021, a total of 1.955 US dollars have been executed. This amount accounts for 20.7% of 9.457M US dollars voluntarily contributed by the KFS in the 3rd Donors' Meeting and 32.5% of the total project fund of 6.008M US dollars covered by the actual project requirements for CY 2021 subject to the consideration of the respective Project Steering Committee (PSC). The project fund execution of three (3) projects implemented in Myanmar (AFoCO/007/2014, AFoCO/014/2020, AFoCO/015/2020) have been affected by the COVID-19 pandemic and internal situation in the country.
- 3. The Secretariat allocates the budget for Program Support Fee (PSF) under the Special Account, in accordance with the AFoCO Financial Regulations which is up to 12% of the basic budget (all budget components which are not a Program Support charge). These funds are deposited as Program Support Fee in the Special Account, to fund project management related activities as follows:
 - inception and closing workshops
 - project monitoring
 - PSC meetings and other project-related occasions
 - mid-term/final evaluation
 - on-call consultancy services
 - annual customized training for IAs & project stakeholders at RETC
 - publication/advocacy activities, and,
 - other expenses related to project administration
- 4. Budget allocation for PSF was made covering approved projects since the 2nd AFoCO Assembly. However, in view of the limitations brought about by the COVID-19 such as on-site travels, project monitoring of the Secretariat and face to face meetings/workshops, the PSF allocation is not being fully utilized. As of 25 October 2021, the amount of 886 US dollars out of a total of 713,746 US dollars was utilized for management of each project.

 - review the update on the Special Account (project fund) of AFoCO and the Program Support Fee, and provide further guidance.

Updates on the Special Account (AFoCO Fund)

At the 3rd AFoCO Donors' Meeting, the Secretariat took note on the requests of the KFS to the Secretariat to put the top priority on project fund execution, particularly in responding to the anticipation of enhanced monitoring requirement of the Korean government on its contributions to the international organizations under newly enacted "Act on Contributions to International Organization". Based on the request from the 3rd Donors' Meeting, the Secretariat have taken follow-up actions as follows:

- To organize a technical meeting on 23 April 2021 to discuss available execution range of 2021 annual budget for the five (5) new projects to be launch on or before 1 July 2021
- To discuss additional activities that can be potentially implemented in 2021, for on-going projects
- To discuss the general guidelines on COVID-19 coping-up measures for AFoCO projects

Since the 3rd Donors' Meeting, the Secretariat has updated the project fund execution for the AFoCO projects to the KFS. As of 25 October 2021, a total of 1.955M US dollars have been executed (Table1). This amount accounts for 20.7% of 9.457M US dollars voluntarily contributed by the Korea Forest Service (KFS) in the 3rd Donors' Meeting and 32.5% of the total project fund of 6.008M US dollars covered by the actual project requirements for CY 2021 subject to the consideration of the respective Project Steering Committee (PSC). The project fund execution of three (3) projects implemented in Myanmar (AFoCO/007/2014, AFoCO/014/2020, AFoCO/015/2020) have been affected by the COVID-19 pandemic and internal situation in the country.
