#### Item 5.1 Updates on promotion of private sector engagement (for Decision)

In accordance with the Work Plan in 2024, the 'Friends of Asia and Asian Forests (FAAF)' Forum was launched on 6 February 2024 as part of promoting and enhancing private sector engagement. FAAF is initially formed among Korean companies and business leaders to support works of AFoCO. The next Forum will be organized tentatively in September 2024, with plans to invite global business leaders and AFoCO ministers.
